Deutsche Bank AG

Deutsche Bank's operational base in Japan. It offers corporate banking services, including commercial banking, trade finance, cash management, commercial real estate, as well as trust and securities services.

Deutsche Securities Inc.

Deutsche Securities Inc. is Deutsche Bank's securities and investment banking arm in Japan. It offers a full range of investment banking services, including sales and trading of equities and bonds, capital raising and M&A advisory. The company has significantly expanded its operating platform in Japan since the late 1990s.

Deutsche Asset Management (Japan) Limited

The Japanese operational base of one of the world's largest asset management groups, Deutsche Asset Management (Japan) offers a spectrum of investment services for domestic and overseas public and private pensions. The company's retail business also offers various mutual funds for private investors in Japan.

DB Trust Company Limited

DB Trust Company is the Trust & Securities Services arm of Deutsche Bank Group in Japan. It provides trust and agency services on asset backed securities (ABS) mortgage backed securities (MBS), as well as traditional corporate debt. Its services include trustee, bond registry, cash management, as well as agent for special purpose companies (SPCs), offering solutions to customers issuing bonds and arranging securitizations, both domestically and internationally.
